Yes, we are as if tied to an irritating and long pandemic situation, but we are not defeated. The human civilization must go on in the midst of all odds. The *Anudhyan 2020* issue was published late in the 1st phase of pandemic situation; while *Anudhyan 2021* issue is coming out after the end of 2nd wave, but surprisingly in time!
